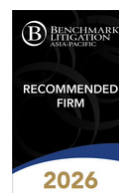

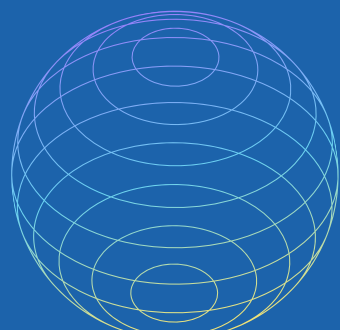

Work Highlights



Successfully secured an award of over RM3 million in equitable compensation for our client, in a lawsuit concerning a breach of trust deed in relation to shares of a Malaysian Company. An appeal filed by the defendant in the High Court was subsequently dismissed. *Eller, Urs v Cheong Kiat Wah [2021] SGHC 253, [2020] SGHC 106*



Presented a compelling defence for our client, who was one of several parties sued by a party to a joint venture. The claimant sought indemnity and damages, alleging that the defendants breached an exit agreement by failing to service a loan. The dispute involved issues regarding contract formation. The Court found that the claimant failed to prove that our client was a party to the exit agreement. *Choong Cher Siong Ronnie v Florensia Leovanny Liong and others, [2022] SGDC 286*



Successfully defended two out of three defendants named in a claim for relief against minority oppression initiated by their investor. The claimant alleged that he had been excluded from conduct of the company's affairs and that his shares were wrongfully diluted. The Court found that there was no unfair dilution of shares. *Lim Tong Zhen Kevryn v Cheo Jean Sheng and others [2022] SGHC 315*

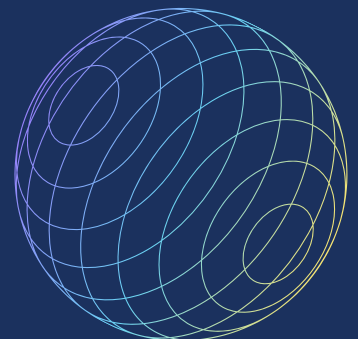

Notable Cases

- Represented an international asset management company in a wrongful dismissal claim by a former employee seeking six-figure damages, revenue-sharing entitlements, and reimbursement of alleged business expenses. We successfully defended the company, with the Court awarding only nominal damages, partial reimbursement to the claimant, and costs in favour of our client. (*Bryon James Murphy v Farrington Asset Management Pte Ltd* [2024] SGDC 288).
- Represented the defendant and plaintiffs-in-counterclaim against claims for commission and salary by a former employee who was their vice president of sales in the Asia-Pacific region. The former employee made claims for commission and salary, but our client disputed the amount of commission due, specifically for projects where the engagement with their clients turned sour. The Judge awarded judgment for less than what the plaintiffs had claimed. (*Appelqvist, Pontus Paal v Eon Reality Pte Ltd* [2022] SGHC 296)
- Represented the plaintiff, a global confectionary supplier in a contractual dispute with its local distributor concerning the wrongful termination of a distribution agreement and unpaid invoices. The case involved complex issues of material breach, estoppel, and waiver. Secured judgment for the plaintiff for USD 199,875.60, with only a partial award of the defendant's counterclaim for reimbursements allowed.
- Successfully negotiated a settlement for a prominent building and construction company in a SIAC arbitration against a main contractor concerning unpaid sums for contracted work and additional works performed, as well as wrongful call on our client's performance bond. We defended against counterclaims filed by the respondent for alleged failure to provide certain goods and rectification of defects.

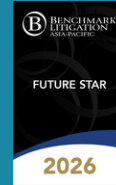

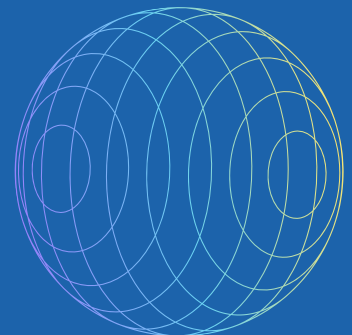

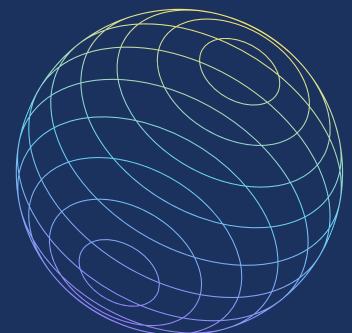

Notable Cases

- Represented the Official Receiver's Office in a novel cross-border insolvency case, where the Court of Appeal had to determine the extent to which Singapore assets could be preserved for payments of locally incurred debts in the winding up of a foreign company. The Court of Appeal found that there was no requirement to ring-fence Singapore assets for payment of local debts where the insolvent company was not registered in Singapore. *Beluga Chartering GmbH (in liquidation) and others v Beluga Projects (Singapore) Pte Ltd (in liquidation) and another (deugro (Singapore) Pte Ltd, non-party)* [2014] 2 SLR 815; [2014] SGCA 14
